Remaining 38 hours are elective and may be subjects listed on KFS-1 excluding EMT and First Aid, which are limited to 38 hours.

\*Any person who had zero (0) career training hours as of July 1, 2000, must also complete the eight (8) hour "Survival" course. These eight (8) hours shall be recorded in Category B. These eight (8) hours are in addition to the currently required two (2) hours for a total of ten (10) hours in Category B.

\*\*Any person who had zero (0) career training hours as of July 1, 2001, must also complete the sixteen (16) hour "Firefighter Survival and Rescue" course. These sixteen (16) hours shall be recorded in Category B and are in addition to the currently required two (2) hours for a total of eighteen (18) hours in Category B. Additionally, any person with zero (0) training hours as of July 1, 2001 must also complete a four (4) hour "Wildland Firefighting Awareness Level" course. These 4 hours shall be recorded in Category M. These 4 hours are in addition to the currently required five (5) hours for a total of nine (9) hours in Category M.

It shall be each department's responsibility to maintain proper documentation that these courses have been completed. This documentation may be subject to audit by the Fire Commission.
